Bids for the construction of the Project will be received at the **Northwestern Water and Sewer District** located at **12560 Middleton Pike, Bowling Green, Ohio 43402**, until **Tuesday, November 23, 2021** at **11:00** local time. At that time the Bids received will be **“publicly” as applicable to the Project** opened and read.

The Project includes the following Work:

Installation of approximately 56,000 lineal feet of 8” waterline install by open cut and horizontal directional drilling, 2,700 lineal feet of 12” river main crossing, relocation of the Liberty Center pump station, and miscellaneous appurtenances such as fire hydrants and gate valves.
