

Northwestern Water & Sewer District – Waterline #200 Drinking Water Consumer Confidence Report For 2015

In 2015 Northwestern Water & Sewer District – Waterline #200 had an unconditioned license to operate our water system. *This institution is an equal opportunity provider.*

Together, the City of Oregon and the Northwestern Water & Sewer District – Waterline #200 have prepared the following report to provide information to you, the consumer, on the quality of our drinking water. Included within this report is general health information, water quality test results, how to participate in decisions concerning your drinking water and water system contacts.

Source Water Information

The City of Oregon receives its drinking water from Lake Erie. The City of Oregon uses surface water drawn from an intake located in Lake Erie near Reno Beach into the Low Pressure Pumping Station. The raw water is then transported to the Water Treatment Plant through 5 miles of 36-inch diameter pipe. Continual monitoring of the chemical feeders and raw water by the plant's operators ensures optimal treatment of the water. Lime and caustic soda for softening, alum for coagulation, carbon dioxide for neutralizing excess lime in solution and chlorine for disinfection are the primary parts of treatment. The water is filtered through 8 rapid sand filters, then stored in underground clear water reservoirs.

What are sources of contamination to drinking water?

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include: (A) Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife; (B) Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming; (C) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses; (D) Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems; (E) Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, USEPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Who needs to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons, such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infection. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Drinking Water Hotline (1-800-426-4791).

About your drinking water.

The EPA requires regular sampling to ensure drinking water safety. The Northwestern Water & Sewer District – Waterline #200 conducted sampling for bacteria and disinfection byproducts during 2015. Samples were collected for a total of 13 different contaminants most of which were not detected in the Northwestern Water & Sewer District – Waterline #200 water supply. The Ohio EPA requires us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, are more than one year old.

The EPA requires regular sampling to ensure drinking water safety. The City of Oregon conducted sampling for bacteria; inorganic; synthetic organic; and volatile organics during 2015. Samples were collected for a total of 64 different contaminants most of which were not detected in the City of Oregon water supply. The Ohio EPA requires us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, are more than one year old.

Listed below is information on those contaminants that were found in the Northwestern Water & Sewer District – Waterline #200 drinking water.

Turbidity

Turbidity is a measure of the cloudiness of water and is an indication of the effectiveness of our filtration system. The turbidity limit set by the EPA is 0.3 NTU in 95% of the daily samples and shall not exceed 5 NTU at any time. As reported above, the City of Oregon’s highest recorded turbidity result for 2015 was 0.09 NTU and lowest monthly percentage of samples meeting the turbidity limits was 100%.

Violations

The Northwestern Water & Sewer District – Waterline #200 had a MCL violation for TTHM for the first, second, third and fourth quarters of 2015. Some people who drink water containing trihalomethanes in excess of the MCL over many years may experience problems with their liver, kidneys, or central nervous systems and may have an increased risk of getting cancer. Northwestern Water & Sewer District – Waterline #200 took/is taking the following steps to correct this violation and prevent future violations from occurring:

We have entered into a Bilateral Compliance Agreement with the Ohio EPA to resolve our drinking water violations. One of the items on the agreement was to commence implementation of a distribution system optimization plan developed by Poggemeyer Design Group, Inc. This plan outlines flushing plans to increase the flow and reduce contributing factors to the formation of TTHM's in the system. With this plan, and the improvements the City of Oregon is making to their water plant we will be able to deliver better quality water to our customers.

Lead Educational Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Northwestern Water & Sewer District – Waterline #200 is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Infants and young children are typically more vulnerable to lead in drinking water than the general population. It is possible that lead levels at your home may be higher than at other homes in the community as a result of materials used in your home's plumbing. If you are concerned about elevated lead levels in your home's water, you may wish to have your water tested and flush your tap for 30 seconds to 2 minutes before using tap water. How do I participate in decisions concerning my drinking water?

Definitions

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Contaminant level (MCL): The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Parts per Million (ppm) or Milligrams per Liter (mg/L) are units of measure for concentration of a contaminant. A part per million corresponds to one second in a little over 11.5 days.

Parts per Billion (ppb) or Micrograms per Liter ($\mu\text{g/L}$) are units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.

Maximum Residual Disinfectant Level Goal (MRDLG): The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Treatment Technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

The "<" symbol: A symbol which means less than. A result of <5 means that the lowest level that could be detected was 5 and the contaminant in that sample was not detected.
