Re: Colony Area Sanitary Sewer Rehabilitation Project Update

Dear Owners/Residents:

Our contractor, Utilicon, will continue working on Riverside, Park, Forest, Eagle Point, and Hillcrest Drives. The contractor will continue the sewer mainline pipe replacement by pipe bursting and excavating and replacing the manholes and sewer tap connections (for each home from the mainline sewer to the Right-of-Way line). Your private sewer lateral will be reconnected by our contractor. This will require a brief disruption in your sanitary service. The contractor will try to schedule it to minimize your inconvenience.

Concrete sidewalk and driveway restoration is currently being performed on areas where the sewer work has been completed. Asphalt pavement restoration and seeding will begin in disturbed areas the week of October 27, 2014 for the first section of work (Riverside Drive up to Colony Drive and portions of Forest Drive and Park Drive will be done in this first pavement restoration phase). Work will continue for the next few months in remaining project areas with final restoration scheduled for next spring. The contractor will be required to place temporary pavement and erosion protection in the project areas and will maintain them throughout the fall and winter.

Please remember that in order to ensure that there are no existing clean water connections at individual residences, our field inspector will contact you in the next several months to set up an appointment to investigate your private sanitary system. The inspector may need access to your home when it is convenient for you. Any clean water connections must be removed at your expense. We have a matching grant program that can pay 50% of this cost up to \$2,000.00 maximum for the removal of clean water connections. Information on this program can be found on our web site. Local traffic to resident's homes will be maintained as much as possible, however, some delays may occur. If special arrangements to access your driveway are needed, please call the project manager, Ray Donald at (419) 354-9090, ext. #173. Utilicon will be responsible for restoring the area and planting grass upon completion of the sewer installation.

We apologize for the inconvenience and the frustrations that come with construction. The good news is that the progress made so far in Rossford has greatly reduced and nearly eliminated nearly all sanitary sewer overflows to the Maumee River. The sanitary sewers in this area were in critical condition. This project should ensure that your sewers will be in good shape for many years. Up to date information regarding each week's progress will be posted on our website home page as well to our Facebook page and the Rossford Record Journal. We appreciate your patience and understanding as we complete this critical project.
